**\*\*Pay online:**

- ) Visit [www.marshall-wi.com](http://www.marshall-wi.com), go to: \*Paying my utility bill online\* - select the Payment Service Network "PSN" link.
- ) You can set up recurring electronic payments, make one time payments, and view your bill.
- ) There is no fee to the customer for use of the online payment system.
- ) For a fee you may use a credit card to pay your bill through the "PSN" system.

**\*\*Pay in person:**

- ) Utility billing office is located in the Marshall Municipal Building, 130 S. Pardee Street, Marshall, WI.
- ) A payment drop slot is available for your convenience on the left hand side of the front entrance to the municipal building.

**PAST DUE BALANCE - LATE PAYMENT AND RETURN CHECK/ACH FEES**

You are responsible for all legitimate, undisputed charges on your bill. If your payments are not made on time your service may be disconnected (pursuant to Wis. Admin Code, Chapter PSC 185) and you may have to pay a reconnection charge to restore your service.

A fee is charged for payments received after the due date or for a check/ACH debit that is returned by the bank for any reason.
