

**VILLAGE OF MARSHALL
RESOLUTION 2022-18**

WHEREAS, the Village of Marshall is duly authorized to charge for various functions, services and permits;

WHEREAS, the exact amount of such fees is and shall be determined by state statute, Village ordinances, or resolutions of the Village board, as may be amended from time to time; and

WHEREAS, the Village Board has concluded that, for reference purposes, it is useful to have single schedule summarizing those fees.

NOW, THEREFORE, the Village Board does hereby resolve that the following is a summary of the fees to be charged as of December 13, 2022.

A. PUBLIC SAFETY (Municipal Code Chapter 5)

1. Open Burning Permit (*requires Village Board approval*) \$ no charge
2. Special Event Permit (Event Outside of Village Park) \$ 50.00

B. PUBLIC WORKS (Municipal code Chapter 6)

1. Excavations of Streets, Alleys, Public Ways & Grounds \$ 25.00 base fee (non-refundable) Plus fees for specified work on the permit form.
2. Street Privilege Permit **\$25.00** plus any actual Village costs (must execute and file a \$10,000 bond with application)
3. Driveway Permit \$ 50.00
4. Contracted Services rates for public works equipment:
 - A. \$40.00/hour per person (minimum charge of 1 hour) PLUS
 - B. Equipment charge: The Village has adopted the State of Wisconsin Department of Transportation 2018 Classified Equipment Rates and each subsequent annual revision of the same or other amendments thereto.
 - C. Materials charge: materials actual cost plus 10%
5. If Village contracts work out, cost is Contractor's costs plus 10% or Village's charge whichever is higher
6. Snow/ice removal on sidewalks by Village employee or contractor.
(Minimum charge is 1 hour plus a 10% administrative fee)
 1. 1 person & equipment \$75.00 per hour

2. Materials for snow/ice removal \$ cost plus 10%

d. Additional fines amount, plus costs shall be charged for the listed offenses in the itemized Village of Marshall Bond Schedule effective July 15, 2009.

F. PARKS AND NAVIGABLE WATERS.

PARKS EVENT FEE SCHEDULE

Use this schedule to aid your event budget planning. Final fee assessment is done by Village of Marshall Parks and Administrative Staff. Private teams, clubs and organizations are subject to all fees applicable.

This schedule is subject to change without notice.

Park Event Fees:

- Programmed Event Scheduling Fee (based on size/complexity of event): \$100
- Successive Day Scheduling Fee \$50-100.00 (based on size/complexity of event)
- Past Application Deadline Fee (less than 30-day notice) \$50.00
- Labor Charge \$50 per hour (2 hour minimum); Damage to property and grounds at cost, plus 10%
- Event Cancellation Charge 15% of total event charges (If not cancelled 2 weeks in advance)
- Bonafide non-profit organizations will receive 50% off rental fees

Park Permits & Vending Fees:

- Beer Selling Permit (from the Village of Marshall): \$10.00 (Licensed Operator required)
- Daily: Resident \$25, Non-resident \$50.00 Event Vending (Up to 7 vendors) \$150
- Additional Days in calendar year: Resident \$15, Non-resident \$25
- Disc golf permit: Annual permit is \$20 and Daily permit is \$5; \$10 to print lost tags.

Equipment and Deposits

- Dumpsters: renter is responsible for obtaining dumpsters
- Key/Cleaning Deposit (forfeited if key is not picked during regular business hours)– (\$50)
- Portable Toilets- Based on the size of the event and the location these may be needed. (Decision made by Park & Rec Dir.) It is up to the renting party to provide them.

Baseball/Softball Field Rental Details:

Converse Park:

- Practice: Residents \$15 per hour, Non-residents \$25 per hour
- Games: Residents \$30, Non-residents \$50, \$20 additional for lights per field per game
- Tournaments: Prices vary on size of tourney and number of teams. Request more details from Park Coordinator or Rec Director.

Concession Stand:

- Parks and Rec must provide a minimum of one concession stand staff as the facility is a licensed restaurant. If Park and Rec is to provide all concession staff, then a 75/25 net revenue split in favor of Marshall. If users provide all but one staff member, then 25/75 net revenue split in favor of user.

Firemens Park:

- Games: Residents \$70, Non-residents \$90 for one game, \$20 additional games; \$30 for lights (additional fees may apply during poor weather conditions for extra field supplies and labor by staff)
- Tournaments: Prices vary on size of tourney and number of teams. Request more details from Park Coordinator or Rec Director.

Concession Stand:

- If Marshall provides concession staff, net revenues would be split 75/25 in favor of Marshall
- If Marshall only provides the concession items, net revenues would be split 25/75 in favor of user
- Proper permitting for food and alcohol sales still apply

H. SUBDIVISION REGULATIONS. (Municipal Code Chapter 14)

1. Preliminary Plats (non-refundable fees) \$100.00 for up to and including six (6) lots, plus five dollars (\$5.00) per each additional lot over six (6).
2. Final Plat Review Fee \$ 25.00 plus \$2.00 for each dwelling unit within the Final Plat at the time of first application for final plat approval
3. Final Plat Re-application Fee \$10.00
4. Certified Survey \$ 50.00/certified survey
5. Amended/revised certified survey \$ 50.00/certified survey
6. Consultant Fees (All consultant fees, including but not limited to planning, legal and engineering fees will be invoiced at cost plus administrative costs - not to exceed 10%).

I. BUILDING CODE. (Municipal Code Chapter 15)

Fees for building, electrical, plumbing and heating/air conditioning permits vary according to the project being done. Current fee schedules may be obtained from the Building Inspector. The Village currently contracts with Independent Inspections, Ltd. for these services.

J. EROSION CONTROL AND STORMWATER MANAGEMENT PERMITS & FILLING AND GRADING PERMITS.

1. Base fee \$ 125.00
 - a. plus .004 for every square foot of disturbed area
 - b. plus .005 per square foot of new impervious area
 - c. plus .0025 per square foot of redeveloped impervious area

The landowner or applicant shall be responsible for any and all costs associated with the review of the plans and calculations by any outside agency the Village of Marshall may use; (ex: consulting engineers, DNR, Soil Conservation, Dane County)
